Preschool Services Allocation:

Preschool services are a hybrid of allocation to all participating districts based on their share of the number of teachers/paraprofessionals in the program. Some districts opt to be charged based on actual utilization. The only exception is that any 1:1 aides within the preschool program are billed directly to the district to which the student belongs.

Program Allocations:

Programs operated by the ESC, such a the REACH program and Opportunity School, are allocated to all participating districts based on each district's percentage of share of total enrollment in program.

Disclaimer:

The rates as listed above are for current as of the 2022-2023 school year. The amounts reflected are for salary only. Additional costs that are incurred to districts include benefits such as medical, dental or vision insurances, STRS or SERS retirement contributions, Bureau of Workers' Compensation premiums, travel, supplies and any legal costs incurred on behalf of particular employee. A 3.5% administrative cost of doing business fee is applied to total costs. Rates reflected above are shown before any applicable state funding that may be received on behalf of a particular employee. If overall contracted services by district exceeds \$1,000,000, a .5% reduction in non consortium services is given
